

Welcome Back! Thank you to all who have helped in the past two weeks as we adjust to a new way of worshipping during this period of COVID-19. At this time I would like to address some issues that have been brought up over the last two weeks and the reasoning behind what we have done here at St. Joseph's. As I told the volunteers who came to our training sessions before we opened. I was most grateful to the following parishioners who assisted me in making the decisions that needed to be made in order to open: Dr. Audra Hanley. Patty Johnson, Jim Poirier, Carol Reynolds, Trustee, Dr. Kerry Ricker & Eric Yager, Ph.D, Our ultimate goal to open was to keep everyone safe. To add to our considerations of what needed to be done was the fact that we have an aging parishioner base. While everyone does have their own personal opinions regarding this virus, I leaned heavily on the medical & scientific information that was given to me by professionals. One area that I struggled with was singing. While there is much that is still unknown, what is known is that singing and loud speaking are both thought to increase the spread of the virus. It was my final decision that, at this time, we would speak all previous sung responses and have instrumental music only. If and when new information is obtained, we may adjust as necessary. The Diocesan guidelines are just that; guidelines. While they do advise that there is to be NO choirs at this time, they also leave open that the parish administration may take a more strict approach based on what is best for their parish. Regarding masks, while there has been much published as to whether or not masks are necessary, the information that I have been given is that there is a form of protection with them. Given that the State is currently requiring masks to be worn in public places, this really is a nonissue. Some parishioners have stated they cannot wear a mask for any length of time and are not able to attend mass for that reason. While I can appreciate the uncomfortable nature of the masks (especially in the warmer months), we must abide by this rule and encourage those who cannot attend to watch and listen to masses via online or TV. I would encourage anyone who has any question(s) regarding our reopening procedures to please contact me directly (518-810-8911) as that is the best way to address specific concerns. Again, in the end, our main concern here at St. Joseph's is the safety of all parishioners. Please remember what is taking place right now is temporary ~ we will get back to where we were before in the very near future. ~~Debbie Griffith
